Self-Nomination for Trustee of the Michigan Credit Union Foundation

Self-nominations are now being accepted for Trustees of the Michigan Credit Union Foundation (MCUF). Eligible individuals may nominate themselves by completing and returning the enclosed self-nomination form.

At their June 2017 meeting, the members of the MCUF will hold an election for three MCUF Trustee positions.

There are seven MCUF Trustees, six with two-year staggered terms; three chosen each year. The Michigan Credit Union League & Affiliates President and Chief Executive Officer David Adams or his designee automatically holds the seventh position.

Three individuals will be elected for a two year term to expire in 2019. All three Trustees with terms expiring this year have indicated they intend to seek re-election.

A person to qualify for election as a MCUF Trustee shall be: (1) a member of, and (2), a director, credit committee, or supervisory committee member, manager/chief executive officer or senior management employee who reports directly to, or recommended by the manager/chief executive officer of the credit union that is a League member in good standing.

The self-nomination form must be received at the Michigan Credit Union League & Affiliates by May 18, 2017. If the number of nominees received is three or more, no nominations will be accepted after May 18, and there will be no nominations from the floor. If there are less than three nominees, nominations will be accepted from the floor.
