In 2016 you helped to raise \$224,885 for our federal PAC. Your credit union's participation in this program helps ensure Michigan credit unions have a strong voice in Washington, D.C.

The official start of the 2017 MCUL Federal PAC Grand Raffle is May 22. This year the Grand Prize Winner will pick their prize of either \$20,000 CASH or \$20,000 towards the price of either a 2017 GMC Sierra 1500 OR 2017 Buick Verano. The raffle will officially commence on May 22, 2017, and run through October 23, 2017. The drawing will be held at the Michigan Credit Union League Headquarters in Lansing, Michigan on Monday, November 20, 2017 at 9:00 a.m. Raffle participants do not need to be present to win, winner must claim prize within 60 days, and no refunds on tickets will be granted. Below is some important information you need to know.

1. Raffle tickets are to be sold by MCUL member credit unions that have signed a valid permission agreement. If you plan to participate in the raffle, election laws require you to sign the permission agreement above. You may already have an agreement on file; however, completing a current form will ensure accuracy.
2. Ticket buyers must be a member of a MCUL-affiliated Michigan credit union and be at least 18 years of age. Regular tickets will be distributed in books of 10 and are to be sold for \$5.00 each. 5 for \$20 discount packs will also be available. Tickets in discount packs are not to be sold individually.
3. Based on how many tickets you ordered last year, MCUL will send you a supply that will meet or exceed that number. Fill out the information above and then return this form to the MCUL.
4. While you may send unsold tickets to other branches, do not pass on unsold tickets to another credit union. Any unsold tickets must be returned to the MCUL to be recorded. Ticket stubs and proceeds must be sent in to the MCUL periodically.
5. You can order more tickets at any time. Just fill out the ticket order form, which comes with your tickets.
6. Regular tickets and discount packs come in stapled books, don't separate them. Be sure your credit union name and seller's name is on each stub. **If you sell to a member of another MCUL-affiliated Michigan CU, please be sure that their CU name AND your CU name are on the stub.** Tickets and money need to be postmarked by October 23, 2017. If you cannot return them by then, please contact Kathryn Hall to make arrangements for a late submission prior to the drawing.
7. When remitting your ticket stubs, please convert cash into a **single** money order or a cashier's check made payable to "MCULLAF." A personal check from a member is also acceptable. Corporate checks are prohibited.
