## Compliance Updates

- **Penny Production Ends — National Rounding Standard in Development**  
America's Credit Unions is urging the U.S. Treasury to provide clarity as penny production ceases. Interim regulatory guidance and a standardized national rounding approach are currently in progress.
- **NCUA Deregulation Wave Continues**  
Four new NCUA proposals aim to streamline operations, including updates to collateral and deposit rules, simplified catastrophic act reporting, and removal of duplicative regulatory requirements.
- **Annual Regulatory Threshold Adjustments Now Effective**  
New thresholds impacting **Regulation Z and M**, qualified mortgage pricing, and **Fannie Mae/Freddie Mac loan limits** have taken effect.
- **Open Comment Opportunities**  
Several NCUA proposals are open for comment, including Parts **701, 704, 740, and 748**, as well as EGRPRA review and CFPB notices.
  - **Deadlines range from February 9–27, 2026.**

## Advocacy Highlights

### State Advocacy (Lansing)

- The Michigan Legislature reconvenes for the second session of the biennium on **January 14**. Bills introduced last year carry over unless previously defeated.
- Ongoing attention remains on the **appropriations process**, following the House's elimination of over **\$640 million** in ongoing project funding. The Senate passed a supplemental bill to restore funding; action now awaits the House.
- MCUL continues work with stakeholders on legislation expanding **investment options for public entities**, addressing concerns related to credit union exclusion and potential deposit impacts.
- Progress continues on **targeted MCUA operational updates** for credit unions.
- The League is closely monitoring potential **state-level interchange legislation**.
- Legislation modernizing Michigan's **Uniform Commercial Code**—including updates for digital assets, electronic signatures, and wire transfers—is expected to be introduced soon.

### Federal Advocacy (Washington, D.C.)

- Congress is back in session, with top priority placed on federal funding ahead of **January 30 continuing resolution expirations**.
- The **National Defense Authorization Act** was signed into law but did not include provisions to enhance the NCUA's Central Liquidity Facility or the CDFI Fund. Importantly, it also did **not** include any harmful interchange provisions.
- America's Credit Unions reaffirmed support for **H.R. 507 — the Veterans Member Business Loan Act**, which would exempt veteran business loans from the MBL cap.

### Grassroots & Advocacy Funding

- **2026 Lapel Pin Program** benefiting MCULAF orders [now open here](#).

- Credit unions are encouraged to consider **payroll deduction** or centralized pin distribution to help offset rising shipping costs.
- Program letters and permission agreement renewal reminders will be sent this month; these agreements are required for communication compliance and do not obligate participation.

## SAS Resources

### New Initiative Coming Soon for Credit Unions Under \$400M

MCUL is launching a new initiative focused on supporting Michigan credit unions with **assets under \$400 million**. The goal is to help smaller and mid-sized credit unions strengthen their business models, improve long-term sustainability, and remain strong and independent.

As part of this work, MCUL will be developing a Strategic Success Playbook that offers practical guidance across key areas such as strategy, financial sustainability, member growth, operations, technology, risk, governance, talent, and execution; reflecting the real-world challenges credit unions face.

The project will begin with a discovery phase that includes a series of virtual listening sessions. These conversations will give credit union leaders an opportunity to share their perspectives and help shape the final resource.
